Grounds and Staging

The event will be held outside on the beautiful lawn behind the Garst Museum. It is surrounded by the Greenville City Park and Darke County Park land. (See photos at www.gatheringatgarst.com) This large parklike setting is bordered on the south by a row of mature trees. No water or electricity is available at this time. This is a rain or shine event. You should be prepared for the elements by providing your own tent/canopy or rent one from us.

Vendors can start setting up on Friday, July 26th Noon–8:00 p.m. All booth set-ups MUST be completed by 9:00 a.m. Saturday. No vehicle parking in vendor area except to unload. No on-site camping available.

Walk-thru security patrol will be provided Friday and Saturday dusk to dawn.
